

**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION
AND ITS CORONA-NORCO CHAPTER 369
AND
THE CORONA-NORCO UNIFIED SCHOOL DISTRICT**

**Year-round to Traditional Track
VanderMolen (Reduction)
January 21, 2022**

This Memorandum of Understanding (MOU) is between the California School Employees Association and its Corona-Norco Chapter 369 (CSEA) and Corona-Norco Unified School District (District). On November 9, 2021, the Board of Education voted to approve the decision to change VanderMolen Fundamental Elementary School (VanderMolen) from a year-round, four-track calendar to a traditional track calendar.

Therefore, CSEA and CNUSD met regarding the effects of changing a VanderMolen from a year-round, four-track calendar to a traditional track calendar. Over the past five (5) years, there has been a steady decline in enrollment. In 2017 student enrollment was at 1,015, and for the 2021-2022 school, student enrollment has dropped to 840.

- b) No bargaining unit member's shift hours shall change as a result of the change from year-round to traditional track.

This MOU is a tentative agreement and shall not be finalized until the completion of CSEA's policy 610 review process.
