**AFTER SCHOOL PROGRAM SITE LEAD (ELOP) INCREASE
November 18, 2022**

This Memorandum of Understanding (MOU) is between the California School Employees Association and its Corona-Norco Chapter 369 (CSEA) and Corona-Norco Unified School District (District). Due to increased funding and need, After School Program Site Lead positions will increase from 5.5 hours to 8 hours and from 9.5 months to 10.0 months.

On November 18, 2022, CSEA and the District met and agreed to increase the number of hours and work year calendars for After School Program Site Lead positions listed below.



If a current bargaining unit member as of November 18, 2022 is in a After School Site Lead position and cannot work the increase in shift hours, the bargaining unit member shall notify Human Resources in writing within 30 days from the notice of change in hours; at which time, the employee will remain 5.5 hours. Once the bargaining unit member vacates the position, the position will move to 8.0 hours.


This MOU is a tentative agreement and shall not be finalized until the completion of CSEA's policy 610 review process.






