## HEALTH ASSISTANT/ LVN INCREASE June 5, 2023

This Memorandum of Understanding (MOU) is between the California School Employees Association and its Corona-Norco Chapter 369 (CSEA) and Corona-Norco Unified School District (District). Due to increased need, there will be increased hours for the below Health Assistant/ LVN positions. The number of months will remain at 9.5.

On June 5, 2023, CSEA and the District met and agreed to increase the number of hours for the Health Assistant/ LVN positions listed below.

- 1. The District will eliminate one vacant 3.5 hour Health Assistant/ LVNs, Position Control Number 125301 and one vacant 5 hour Health Assistant/ LVN, Position Control Number 295301.
- 2. Unit members shall have the first right of refusal to the increased hours based on seniority.
- 3. If a current bargaining unit member as of June 5, 2023, is in a Health Assistant/ LVN position and cannot work the increase in shift hours, the bargaining unit member shall notify Human Resources in writing within 30 days from the notice of change in hours; at which time, the employee will remain at the current hours. Once the bargaining unit member vacates the position, the position will move to the newly established hours.

This MOU is a tentative agreement and shall not be finalized until the completion of CSEA's policy 610 review process.
